Open access comes in three main forms:

Gold Open Access is when the publisher makes the article available, either as a:

- (Full) Open Access publication, when the article is published in a journal, all of the content

- Hybrid Open Access is when the author can choose to pay the publisher a fee for the extra

Green Open Access is when the author him or herself makes a version of the publication openly available

- Parallel publishing or self-archiving, when a version of an article is made openly available

t of which is openly available. There is no subscription or access fee to readers but some journals charge a service to make the article openly available in a subscription journal. In hybrid journals, only some articles are made openly available, for example, by depositing the article in an open archive or repository, by researchers at ÅAU for instance in the Research Information System.
